Either party may terminate this agreement upon 30 days written notice. It is agreed and understood that the inspection issued, in no way constitute a warranty or a guarantee either expressed or implied of the condition of the vessel. THE INSPECTION REPORT ISSUED IS SUBJECT TO THE CONDITION THAT IT IS UNDERSTOOD AND AGREED THAT BOATWATCH,LLC AND *IOR* THE ASSIGNED INSPECTOR SHALL UNDER NO CIRCUMSTANCES WHATSOEVER BE HELD RESPONSIBLE IN ANY WAY FOR ERROR IN JUDGMENT, DEFAULT, OR NEGLIGENCE, OR ANY INACCURACY, OMISSION, MISREPRESENTATION OR MISSTATEMENT. If there is any dissatisfaction with the services provided, it is understood that the total compensation to the client shall be limited to the return of the fee paid for the specific inspection or service.
